Brighthouse SmartCare is an indexed universal life insurance policy that provides long-term care benefits through riders.

Brighthouse SmartCare® can offer growth opportunities and protection from market loss. Although the guaranteed LTC benefit amount is defined in the contract language and illustration, this initial benefit amount can grow based on the chosen LTC coverage option.

LTC Coverage Options¹

- 01** **The Indexed LTC option** can help grow your LTC benefit, death benefit, and cash value by tracking the performance of major market indices up to an annual Cap Rate. These indices are diversified among large-cap, small-cap, and international stocks.²
- 02** **The Fixed Growth LTC option** earns 5% compound growth annually.
- 03** **The Level LTC option** allows benefits to remain the same over time.

Policyholders who elect to link to an index or indices will be credited interest based on Cap Rates and Floor Rates at the end of each 1-year term. If index performance is positive at the end of term, the lower of the Cap Rate or index performance is credited to the Indexed Account. Likewise, if index performance is negative, we absorb the loss and the Indexed Account is credited with a 0% Floor Rate.

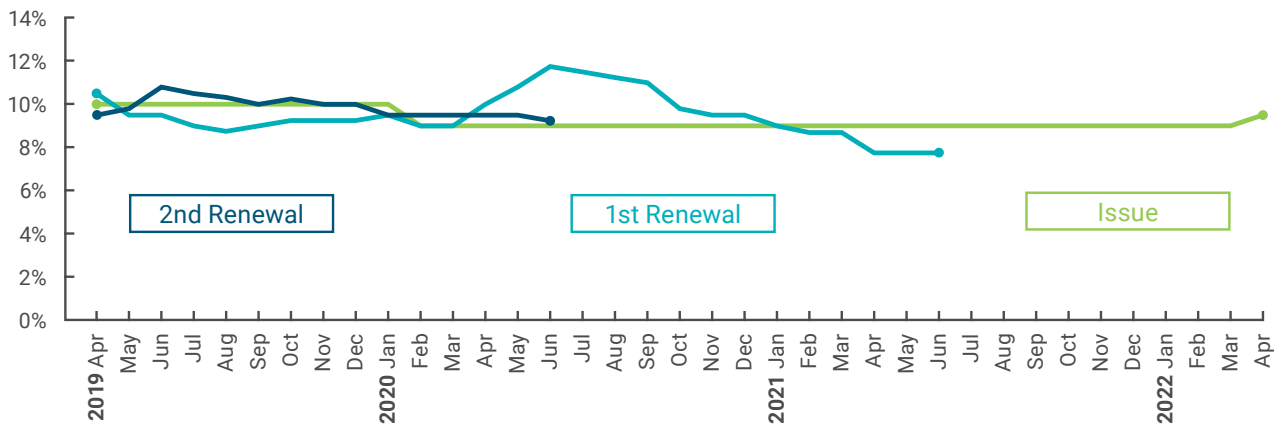

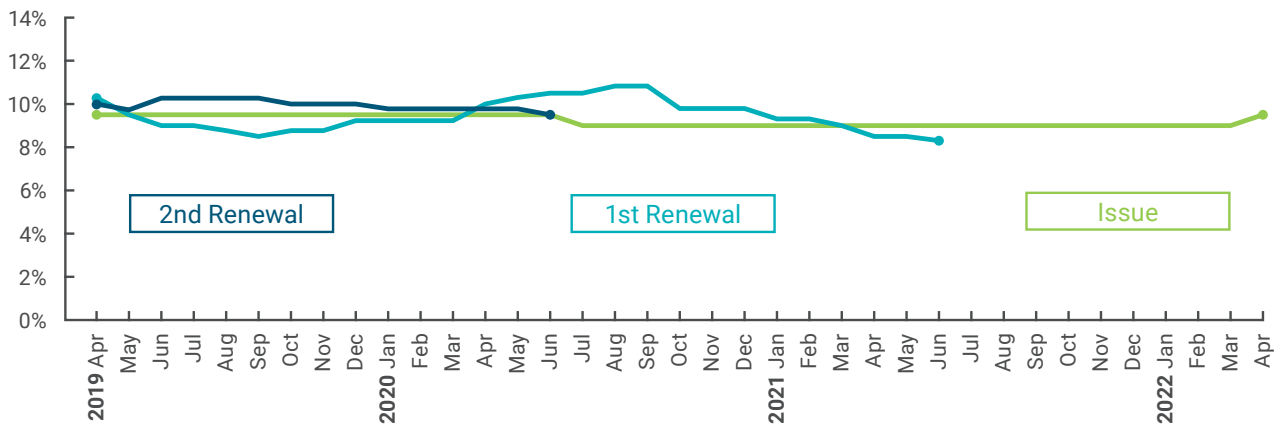

S&P 500® Index

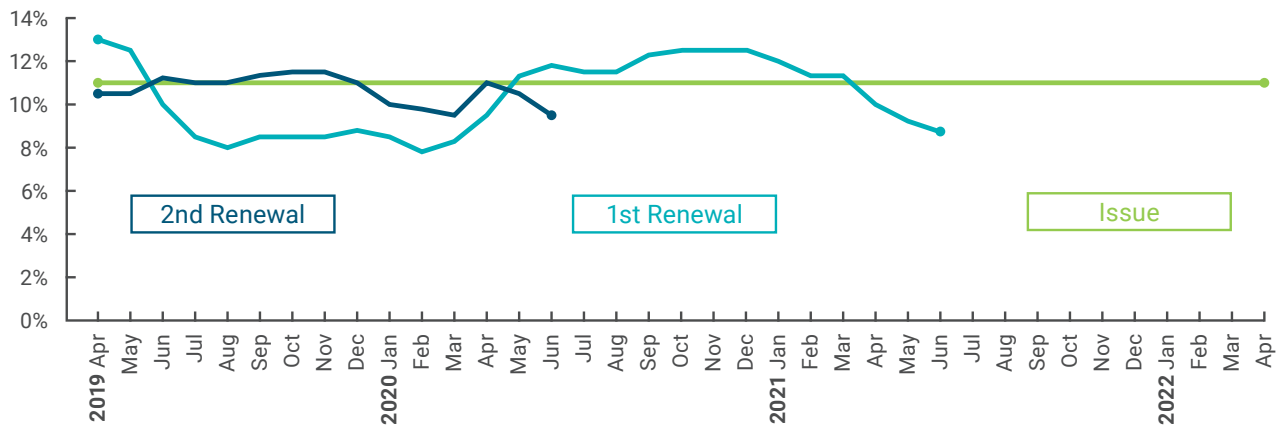


Russell 2000® Index
